# PACOC MOST RECENT LEGISLATIVE REPORT -

## MOAA PA Council of Chapters March 8th Legislative Report

The only major veteran legislation that moved during the budget hearings has been SB 129 that keeps the PA War Veterans Council in its role of submitting veterans for appointments to the state veterans' homes Advisory Councils. It also expands the residents on the Advisory Council to include two members from the home, instead of one, and a family member of a patient or former patient. The bill passed the Senate and has now been voted out of the House VA&EP Committee. The bill has not been assigned to another committee at this time.

The House Veterans Affairs Committee Executive Director has mentioned that three legislators have an interest in drafting a Claims Sharks bill and they are reviewing the PA War Veterans Council Legislative Committee input for the bill. The bill introduced last session as SB 1145 is going to be reintroduced again in the Senate. These bills will put a penalty into PA law that makes it illegal for an individual or company that changes a veteran to file their initial clam, which is prohibited by VA regulations. Only after the veteran's initial claim is denied, can anyone help a veteran file an appeal and charge a limited fee from the lump sum payment, only. Legislation from last session only suggested a penalty of a third-degree felony, a slap on the wrist. Efforts will be made to increase the penalty based on the amount a veteran is overcharged based on the VA thirty percent limit of a lump sum payment.

The PWVC Requested a meeting with the House Veterans Affairs chairmen and their executive directors to discuss three issues from our legislative goals. That meeting will be on March 21<sup>st</sup> with a time to be determined. The three goals to be discussed are an increase in the Blinded Veterans, Paralyzed and Amputee Veterans Pension, to Pass a Claims Shark Bill to protect veterans filing for VA benefits and Sponsor a Joint House and Senate Resolution to support the MAJ Ricard Star Act to send to the Pennsylvania Congressional Delegation to cosponsor and support the bill.

#### **NEW State Legislation Coming:**

A new bill will be introduced again in the PA House to include our fellow MOAA members of the US Public Health Service (USPHS) and National Oceanographic and Atmospheric Administration (NOAA) to be included with the other uniformed services to be eligible for a state tax exemption if they are assigned to work out of state for their job. MOAA PA Council will be assisting with passage

of the bill when it is introduced. Ther are 40 members of the USPHS assigned in PA. The number of NOAA officers has yet to be determined. PA has two National Weather Service offices in State College and Pittsburgh, but not sure if they have any commissioned officers assigned. Bob gray will notify chapter presidents when legislation is introduced to have your member sontact their state representatives to support the bill.

#### Memo

Currently in Pennsylvania, state tax relief is extended to only the four uniformed services contained within the Department of Defense (Army, Navy, Air Force, and Marines), as well as to the US Coast Guard contained within the Department of Homeland Security. However, the uniformed services of the US Public Health Service (USPHS) and the National Oceanic and Atmospheric Administration (NOAA) are excluded from this benefit. As a veteran, I understand the hard work and sacrifices of all uniformed armed forces members, and I believe they should be treated fairly and equally regarding income tax exemption.

My legislation would expand state tax relief to now include USPHS and NOAA members while they are on active duty (or active-duty orders) outside Pennsylvania. Both USPHA and NOAA serve vital roles for our nation's health and well-being and have brave and honorable officers who routinely go "into harm's way" in service to our country. For example, one Pennsylvania USPHA officer who lives in my district was deployed to Liberia to help coordinate the response to the Ebola outbreak. While there, he served alongside members of the Army, Navy, Air Force, and Marines who were responding to this public health crisis – but his income was taxable in Pennsylvania, while their income was not.

Please join me in including valuable USPHS and NOAA members alongside their uniformed comrades to exempt their income taxes while on active duty outside the Commonwealth of Pennsylvania. This is just one of many ways we can show our appreciation for their sacrifices.

## Major General John R. Pippy Sworn in as Pennsylvania's 55th Adjutant General; Assumes Command of the Pennsylvania National Guard

Governor Josh Shapiro presides over swearing in and assumption of command ceremony at Fort Indiantown Gap

**Annville, PA** – Today, Governor Josh Shapiro administered the oath of office to Major General John R. Pippy, Pennsylvania's 55<sup>th</sup> adjutant general and head of the Department of Military and Veterans Affairs (DMVA). In addition to his cabinet-level position, Pippy also assumes command of the Pennsylvania National Guard, the third largest in the nation.

Unanimously confirmed by the Pennsylvania State Senate on Feb. 4, MG Pippy, a western Pennsylvania native and a West Point graduate, brings decades of leadership experience in the National Guard to DMVA.

"Ensuring the PA National Guard is able to effectively serve our communities, our Commonwealth, and our country and that the DMVA is able to deliver for Pennsylvania service members, veterans, and their families is critically important to my Administration," said **Governor Shapiro**. "Major General Pippy has the experience and readiness to lead — and I look forward to working with him and the men and women of the PA National Guard and the DMVA to continue delivering for all Pennsylvanians."

"I am honored and humbled to lead the Pennsylvania Department of Military and Veterans Affairs in its dual mission," said **MG John R. Pippy**. "The first, is the readiness of the Pennsylvania National Guard to respond to the needs of Commonwealth and country when called upon. The second is to fulfill our nation's solemn obligation to take care of our veterans and their families. I am fully committed to serving Pennsylvania as its 55<sup>th</sup> adjutant general."

The Military Officers Association of America (MOAA), is an independent, nonprofit organization, located in Alexandria, Virginia, and operated exclusively to benefit our Nation, its uniformed services personnel, their families and survivors. MOAA was founded February 23, 1929, in Los Angeles, California, with 63 members. The founders believed that retired officers as well as their families and survivors would benefit greatly by joining together in an association — one that would counsel and render assistance to all officers in matters relating to their retired status. Colonel Arthur T. Marix, USMC (Ret), was founder and first President.

In 1944, with membership at 2,600, the Association moved to Washington, D.C. During the next 13 years — from 1944 to 1957— membership reached 25,000, the staff expanded to 19 persons, legislative liaison (lobbying) began, a scholarship loan program was started and *The Retired Officer Magazine*, (now called *Military Officer* magazine), first went to press on a bimonthly basis.

Today, with more than 370,000 members (including 64,000 surviving spouses who are auxiliary members), a staff of 30 retired officers and 60 other support personnel, the National Headquarters administers the Association's many programs that benefit its members, responds to their requests for assistance, and represents the membership to the White House, the Congress, the Defense Department, and other government agencies.

MOAA is a full service organization, with legislative activities; member services such as banking, insurance, and travel; a one-of-a-kind job matching operation for members leaving the services; an award-winning monthly magazine; a quarterly magazine; an award winning web site and benefits information, where members can have individual military benefit questions answered. The MOAA Scholarship Fund has given nearly 8,000 students interest-free loans totaling over \$33 million since its inception in 1948.

After a membership vote in September 2002, the Association changed its name from The Retired Officers Association (TROA) to the Military Officers Association of America (MOAA), on January 1, 2003.

Although MOAA is national in scope, there are approximately 416 organized autonomous local chapters affiliated with the national organization. They are active in local and state affairs affecting the entire officer community, including regular and reserve, of the seven uniformed services — Army, Navy, Air Force, Marine Corps, Coast Guard, U.S. Public Health Service and National Oceanic and Atmospheric Administration Commissioned Officers (NOAA Corps).

Membership in MOAA is open to any person who holds or has ever held a warrant or a commission in any of the seven uniformed services. Surviving spouses of deceased members or other individuals who had been eligible for membership qualify for auxiliary membership in the Association.


